- **4.** The tenders will be opened on 08/06/2015, 3:00 pm, in the presence of tenderers or their representatives if any. Only Envelope-1 shall be opened on this date & time.
- **5.** The bidders shall be qualified after scrutiny of credentials.
- **6.** Envelope-2 shall be opened only of qualified bidders, on notified date & time, in the presence of qualified tenderers or their rep., if any. The notification shall be available on website.
- **7.** When no rate has been quoted for any item, leaving space both in figures, words and amount blank, it will be considered that the tenderer has included cost of this item in other items and rate for such item will be considered as zero and work will be required to be executed accordingly. Tenderers must ensure that all the prints of downloaded document should be of good quality. Vogue /poor quality of printed documents and incomplete documents will not be accepted. The decision of TOC in the matter will be final.
