Sealed tenders are hereby invited in two envelope system, for the below mentioned work from the National level telephone service providers having valid license for provision of basic Telephone service in Delhi service area.

1. The tenders shall not be issued physically. The interested and eligible parties are to download the complete tender document from website <u>www.nplindia.org.</u>

2. The tenderers shall be required to submit the bids in two envelopes (envelopes should super scribed with envelope no. & documents in envelope).

Envelope- 1:- Technical bid will contain the following:-

- (A) Tender Fee& EMD.
- (B) Valid license for provision of basic telephone service in Delhi service area.
- (C) Complete tender document downloaded from website marked as Technical Bid along with compliance report from the bidders and duly signed.
- (D) Other relevant documents like company profile, list of clients etc.

In case any of the above documents is found missing or non satisfactory, the tender may be rejected. Envelope-2 of such agencies shall not be opened.

Envelope-2:- Will contain Financial Bid .

(3). Prebid conference shall be held on 26/10/2015, at 2.30 PM in conference room on 2nd floor, NPL main building. The minutes of prebid meeting shall be available on website.

4. Envelope-1 & 2 are to be sealed (lakh sealed) separately. Both the envelope are to be sealed in bigger size envelope. The tenders are to be dropped in the box <u>kept in the office of undersigned latest by 2:30 pm on</u> <u>03/11/2015.</u>

5. The tenders will be opened **on 03/11/2015, 3:00 pm,** in the presence of tenderers or their representatives if any. Only Envelope-1 shall be opened on this date & time.

6. The bidders shall be qualified after scrutiny of credentials.

7. Envelope-2 shall be opened only of qualified bidders, on notified date & time, in the presence of qualified tenderers or their rep., if any. The notification shall be available on website.

8. When no rate has been quoted for any item, leaving space both in figures, words and amount blank, it will be considered that the tenderer has included cost of this item in other items and rate for such item will be considered as zero and work will be required to be executed accordingly. Tenderers must ensure that all the prints of downloaded document should be of good quality. Vogue /poor quality of printed documents and incomplete documents will not be accepted. The decision of TOC in the matter will be final.

9. Conditional tenders & tender with use of fluid shall be rejected.

10. The tenderer shall not be permitted to tender for work in the concerned unit of CSIR in which a relative is posted in the grade between Controller of Administration and Junior Engineer (both inclusive). He shall also intimate the names of persons who are working with him in any capacity or subsequently employed by him and who are relatives as mentioned above.

NOTE: A person shall be deemed to be a relative of another if, and only if, (a) they are members of a Hindu undivided family; or (b) they are husband & wife, or (c) the one is related to the other in the following manner: Father, Mother (including step mother), son (including step son), Son's son's son's son's son's wife, son's daughter, son's daughter's daughter's daughter's daughter's daughter's husband, Brother (including step brother), Brother's wife, Sister (including step sister), Sister's husband.

Tender submitted shall remain valid for 90 days from the date of opening for the purpose of acceptance and award of work, validity beyond 90 days from the date of opening shall be by mutual consent.
 The tenderer shall quote rates both in figures and words failing which, tender is liable to be rejected. On check if there are differences between the rates quoted by the tenderer in words and in figures or in the amount worked out by him, the following procedure shall be followed:

(i) When there is a difference between the rates in figures and in words, the rates which correspond to the amounts worked out by the tenderer shall be taken as correct.

(ii) When the amount of an item is not worked out by the tenderer or it does not correspond with the rate written either in figures or in words, the rate quoted by the tenderer in words shall be taken as correct.

(iii) When the rate quoted by the tenderer in figures and in words tallies but the amount is not worked out correctly the rate quoted by the tenderer shall be taken as correct and not the amount.

13. Before tendering, the tenderer shall inspect the site to fully acquaint himself about the condition in regard to accessibility of site, nature and extent of ground, working condition of site and locality including stacking of materials, installations of tools and plants (T&P) etc., conditions affecting accommodations and movement of labour etc. required for the satisfactory execution of the work contract. No claim whatsoever on such account shall be entertained by the Employer in any circumstances.

14. Earnest money will be forfeited if the contractor fails to commence the work as per letter of award.15. Except writing rates and amount, the tenderer should not write any conditions or make any changes, additions, alterations and modifications in the printed form of tenders. Tenderers who are desirous to offer rebate the same should be brought out separately in the covering letter and submitted along with the tender.16. EMD of successful bidder shall be refunded immediately after completion of contract/work.

ARBITRATION CLAUSE:

(a) Except where otherwise provided in the contract, all questions and disputes relating to the interpretation of the specifications, designs, drawings and instructions herein before mentioned, and as to the quality or workmanship or materials used on the work or as to any other question, claim, right, matter or thing whatsoever in any way arising out of or relating to the contract, designs, specifications, estimates, instructions, orders-on these conditions or otherwise concerning the works, or the execution or failure to execute the same, whether arising during the progress of the work or after the completion or abandonment thereof shall be referred to the sole arbitration of the person appointed by the Director-General, Council of Scientific and Industrial Research. The arbitrator shaft be appointed within 30 days from the receipt of a request by any party. The arbitrator to whom the matter is originally referred, being unwilling or unable to act for any reason, the Director-General shall appoint another person to act as of Arbitrator in accordance with the terms of the contract, such person shall be entitled to proceed with the reference from the stage at which it was left by his predecessor. The arbitrator shall give a speaking award. The award of the Arbitrator shall & final and binding on the parties. The cost of the Arbitrator shall be borne equally by both the parties.

(b) It is also a term of the contract that the party invoking arbitration shall specify the dispute or disputes to be referred to arbitration under this clause together with the amount or amounts claimed in respect of each such dispute.

(c) It is also a term of the contract that if the contractor does not make any demand for arbitration in respect of any claim in writing within 90 days of receiving the intimation from the Employer that the final bill is ready for payment, the claim of the contractor will be deemed to have been waived and absolutely barred and the Employer shall be discharged and released of all liabilities under the contract in respect of these claims.

(d) Subject as aforesaid the provisions of the Arbitration and conciliation Act, 1996, or any statutory modification or re-enactment thereof and the rules made there under and the time being in force shall apply to the arbitration reference under this clause. -

GENERAL CONDITIONS AND SPECIFICATIONS OF THE SYSTEM

1. NPL-CSIR is premier constituent laboratory of CSIR. The existing contract of contract facility is likely to expire with in a short period. The agency who is awarded the new contract, may either take over the existing infrastructure from Existing agency (NPL will not be responsible for such arrangement, it will be a purely mutual in between existing service provider and new one.) or may create their own infrastructure including necessary cabling work. If new infrastructure is required to be created by the agency, the work should be completed within two months of award.

2. Any damage made to NPL infrastructure during work should be made good by the service provider free of cost.

3. Initially 525 lines capacity will be installed in the premises but the service provider shall ensure the provision

of 10% increase, If require.

4. Maintenance of the system & telephones will be responsibility of service provider without any further charge beyond quoting in financial bid.

5. The NPL shall provide floor space for equipment.

6. The actual location for individual telephones to be installed will only be provided at the time of actual execution of order.

7. NPL has satellite buildings within its campus and the Centrex facility is to be extended to all these buildings. It shall be the responsibility of the quoting agency/vendor to have a physical survey of the site, before submitting the offer. The service provider will include all costs, including all cable lying to the actual locations of the instruments.

8. The service provider will confirm that the free calls quota available for each of the lines will be pooled and adjusted against the total external calls/STD/ISD made from all the Centrex exchange lines.

9. The service provider will indicate extra expenses for installation and operation of any of the facilities mentioned in the table.

10. The service provider will enable NPL for automatic disconnection of external calls facility from any of the telephone connection. It would be desirable that this provision can be selectively implemented on some of the lines installed in the system.

11. Caller ID telephone instruments will be provided for all lines.

12. During contract any telephone can be shifted from one room to other room & defective telephone will be repaired/replaced by the service provider free of cost.

13. Billing of all telephones line will start after completion of total installation work, the billing will be on monthly basis.

14. Before quoting rates the intended bidder is advised to visit the site.

15. Average call used by each telephone is 200 nos approx.

16. Rates will be same through out contract period.

17. Service taxes if any will be extra, as applicable.
