Performance Security

15. The successful bidder shall have to deposit Performance Security/ Security Deposit for an amount of 10% of the total value of contract in form of an A/C payee Demand Draft/Fixed Deposit Receipt/ Bank Guarantee from a commercial Bank in favour of "**Director, National Physical**

Laboratory," payable at New Delhi

Penalty Clause

- 16. Penalty clauses shall be as under:-
 - (a) If it is found that Fire Extinguishers have not been serviced, refilled / replaced as per specifications of BIS of weight & performance, the same will be returned at the cost and risk of the Firm & deduction @ 10% of the total bill shall be made depending upon the severity of the deficiency in service, DNPL reserve the right to blacklist the agency and forfeit its performance security.
 - (b) The refilling of Fire Extinguishers should be completed within 04 weeks of the issue of job order failing which penalty @ 0.5% per week subject to maximum 10% of the order value will be imposed upon the firm.

Risk Clause:

17. If the Bidder after submission of tender and due acceptance of the same i.e. after the placement of order fails to abide by the terms and conditions of these tender documents, or fails to provide services / supply the material as per work / delivery schedule given or at any time repudiates the contract, the DNPL will have the right to forfeit the EMD or invoke the Performance Security deposited by the Bidder and procure the stores from other agencies at the risk and consequence of the supplier. The cost difference between the alternative arrangement and Bidder's tender value will be recovered from the Bidder along with other incidental charges including custom duties, taxes, freight and insurance etc. In case, NPL is forced to procure the Services / material through alternative sources and if procurement price is lower, no benefit on this account would be passed on to Bidder.
