Sealed tenders are hereby invited for the below mentioned work from the contractors, registered with CPWD/PWD/Railways/MES/other Govt. Dept., in appropriate class and have carried out similar works. for CSIR / Semi Govt. Dept./Pvt. Organisations.

The receipt of applications supported by copies of self attested credentials including registration in appropriate class (with proof of bidding capacity more than estimated cost), VAT/S.T. registration & copy of return file within last 06 months, satisfactory completion certificates, for issue of tenders, shall be stopped by 27/08/2014, 05 PM. Tender documents shall be issued to the eligible firms up to 28/08/2014, 05 PM, from the O/o the undersigned, on payment of tender fee. The firms who have started & completed satisfactorily the minm. one/two/three similar works (Building work with better finishes like tile work, stone work etc.) each costing not less than Rs196.15Lacs/ Rs.122.60lacs/Rs.98.07lac respectively within last seven years ending on 31/07/2014, need only to apply for issue of tenders. The satisfactory completion certificates should indicate the name and scope of work (If scope of work is not mentioned in completion certificate, the agency may attach any other proof like copy of agreement showing similar scope of work), date of start, date of completion & completion cost etc. Tenders in double seal (tender document & EMD in separate envelope, both envelopes sealed in one envelope) will be received in the O/o undersigned up to 2.30 pm on 01/09/2014 & will be opened on the same day at 3.00 pm in the presence of tenders, if any. The firms who have executed the work for Pvt. Organisations are necessarily to produce T.D.S. certificates for issue of tenders. The validity of tender will be 90 days after opening of the same. For any dispute arising in between the contract agreement, latest CPWD norms will be followed. **Conditional tenders, tenders without full earnest money in required form, & tender with use of fluid, shall be rejected. If contractor left any rate column blank, the rate this item will be treated as zero.**

The tender document may also be downloaded from website www.nplindia.org. The Tender document will be available for downloading upto last date & time of issue of tender. In case the contractors want to use the downloaded version of tender document, Ist envelope will contain tender fee, EMD & contractor's credentials as above. The contractor is to indicate the name & telephone nos. of issuing agency of the completion certificates to enable to TOC to verify the documents, if necessary.

IInd envelope will contain complete tender document. For downloaded tenders, the tender documents of only those firms will be opened, whose credentials are found in order and to the satisfaction of Tender Opening Committee. The downloaded tenders with incomplete /doubtful credentials, shall be straightway rejected. No further clarification will sought from the tenderer. Tenderers who opted downloaded version for tender must ensure that all the prints of downloaded documents should be of good quality. Incomplete/Vogue/poor quality printed documents will not be accepted. The decision of TOC in the matter will be final. The NIT is also available at website www.nplindia.org. & www.tenderhome.com.
