- 3 All bank charges in the exporting country will be on the exporters account.
- 4 The blue/catalogue/pamphlets/literature and Instruction Manual must be attached along with your quotation/performs invoice.
- The shipment through courier services will not be accepted unless beneficiary takes the responsibility of delivery of goods at NPL. But in that case payment shall be made after receipt of goods at NPL.
- 6 The shipment must be affected through our consolidation agent. The details of our consolidation agent will be indicated in our order.
