Applications are invited from the citizens of India for filling up the following positions at National Physical Laboratory, New Delhi (a constituent laboratory of CSIR) as per details given below. The National Physical Laboratory, a premier institution in the family of Council of Scientific & Industrial Research (CSIR), is devoted to R&D activities in the following areas.

#### 1. Standards

R&D, maintenance and upgradation in calibration and measurement in areas such as, Mass, Volume, Density, Viscosity, Length, Temperature, Optical radiation, Force, Pressure, Vacuum Torque, Hardness, Acoustics, Ultrasonics, Fluid Flow, Magnetism, Electrical power, voltage, current, frequency, impedance, attenuation, Time, etc.

## 2. Materials development and Characterization

Research and Development of materials, processes and technologies in the areas of Metals & Alloys, Carbon technology, advanced ceramics, Polymeric & Soft Materials, Liquid Crystals, Single crystals, Thin film technology, Optical coatings, Superconductors, Ferrofluids, Photovoltaics, Luminescent Materials and Devices, Light emitting diodes, Porous silicon, nanoparticles, sensors, Certified Reference Materials, etc. NPL is having many advanced and sophisticated characterization facilities like AFM, Powder XRD, HRXRD, SEM, TEM, EPR, FT-IR/Raman, UV-Vis., AAS, ICPES, SIMS, PL, AES, LEED, XPS, STM(UHV) etc. to meet the requirements of in-house as well as other Institutions/Industries.

## 3. Radio and Atmospheric Sciences

R&D programmes pertaining to Radio Propagation and Media (Tropospheric and Ionospheric) Characterization includes modeling, effects of space weather, Atmospheric Sciences with a special focus on Global Change, effect of green house and other toxic gases. Study of Antarctic environment with a large number of radio, acoustic and optical techniques is another important activity. NPL has a network of Ionosondes, GPS and Tomographic receivers. Indian regional warning centre (RWC-India) is one of the international facilities for providing space-weather alerts to the users in the country.

# 4. Support units for Organization and Management

For its organization and Management, NPL has several Scientific/Technical Support units like Central Computer Facility (CCF), Library, Central Workshop, Quality control, Photography, Transport, Hindi Unit, Director's Secretariat, Administration, Finance & Accounts, Stores & Purchase etc.

## **General Conditions:**

- a) The posts carry usual allowances as admissible to Central Government employees as made applicable to CSIR employees of the same pay and status stationed at New Delhi.
  - b) Deserving candidates may be considered for higher start of pay.
  - c) The post is pensionable based on defined contribution under the New Pension Scheme which has been in vogue with effect from 01.01.2004.
  - d) The number of vacancies indicated against each category are provisional and may vary at the time of selection.

### 2. Age Relaxation:

- a) The date for determining the age limit/experience/qualifications shall be the closing date prescribed for receipt of applications i.e. 30.04.2010. The upper age limit is however, relaxable upto 5 year for SC/ST and 03 years for OBC as per Government orders in force only in those cases where the post are reserved for respective categories.
- b) SC/ST/OBC candidates are required to produce attested copy of community certificate in the prescribed format along with the Application Form.
- c) Relaxation in the upper age limit for Physically Handicapped will be 5 years, over and above SC/ST/OBC as the case may be.
- d) Candidates belonging to Other Backward Classes (OBC) must submit a photocopy of the latest certificate in the prescribed form issued by the specified competent authority (SDO/District Magistrate/ Dy. Commissioner) along with the Application Form. The certificate issued by Gazetted Officers should be countersigned by the District Magistrate or Dy. Commissioner. OBC candidates will be considered as per CSIR/Govt. of India rules.
- e) Relaxation in the upper age limit of 5 years applicable for the persons who had been domiciled in the Kashmir Division of the State of J&K during the period of 01.01.1980 to 31.12.1989 subject to production of a certificate from the District Magistrate in the Kashmir Division within whose jurisdiction he/she had ordinarily resided OR from any other authority designated in this behalf by the Government of J&K State to the effect that he/she had ordinarily been domiciled in the Kashmir Division of State of J&K during the period from 01.01.1980 to 31.12.1989.
- f) Relaxation in age limit for Ex-Servicemen will be as per Government of India Rules.
- g) Relaxation in age, qualification and/ or experience may be permitted if sufficient number of candidates possessing the requisite qualification and/ or experience are not likely to be available to fill up the posts.

### 3. How to Apply & Application Fee

- a) Prescribed Application form should be downloaded from NPL website <u>www.nplindia.org</u>. Completed application(s) in all respects, supported by attested copies of certificates of educational qualifications, experience, etc together with an application fee (if applicable) of Rs.100/- (Rupees One hundred only) in the form of crossed Demand Draft valid for at least 6 months in favour of Director, National Physical Laboratory payable at New Delhi is to be sent in an envelope superscribing *Application for the post (post applied for with Post code)* to the Controller of Administration, National Physical Laboratory, Dr. K S Krishnan Marg, New Delhi –110012, so as to reach on or before <u>30.04.2010</u>.
- b) Candidate belonging to SC/ST/Physically Handicapped category and regular employees of CSIR are exempted from payment of application fee.
- Separate applications along with appropriate fees are to be made for different posts if a candidate is desirous of applying for more than one post.
- d) Applications from employees of Government Departments will be considered only if forwarded through proper channel, certified by the employer that the applicant will be relieved within one

- month of the receipt of the appointment orders, if selected. Also, vigilance clearance should also be recorded. However, advance copy of the application may be submitted before the closing date. Applications routed through proper channel should reach NPL at the earliest.
- e) Candidates should specifically note that the applications received after the closing date for any reason whatsoever (such as envelopes wrongly addressed, delivered elsewhere, postal delay etc.) will not be entertained by NPL. Any enclosure received separately subsequent to the receipt of the application cannot be connected therewith. No representation in this regard will be entertained.
- f) Incomplete application (i.e. without photograph, without attested copy of educational certificates/experience certificate, unsigned and blank columns will not be entertained and will state rejected.

## 4 Mode of Selection:

- a) Mere fulfillment of educational qualifications and experience does not entitle a candidate to be called for interview. The duly constituted Screening Committee will adopt its own criteria for short-listing the candidates to be called for interview. Only those candidates, who are in the opinion of the Institute, suit the Institutional requirements, will be called for interview. The candidate should therefore, mention in the application all the qualification and experiences in the relevant area over and above the minimum prescribed qualification supported with documents.
- b) Candidate should ensure that he/she possesses educational qualification/experience in the relevant area as required in the category/post, for which he/she is applying, on the last date of receipt of application
- c) The period of experience in the requisite discipline/area of work wherever prescribed shall be counted w.e.f. the date of acquiring the prescribed minimum educational qualifications required for that post.
- d) Only outstation candidates called and found eligible for interview will be paid to and fro single second class rail fare from the actual place of undertaking the journey or from the normal place of their residence whichever is nearer to New Delhi Railway Station on production of Rail Tickets/Rail Ticket Numbers or any other proof of journey. Any discrepancy found between the information given in application and as evident in original documents will make the candidate ineligible for appearing in interview. Such candidate will not be paid any fare.
- 5 Canvassing in any form or bringing of any influence, political or otherwise, will be treated as a disqualification.
