**Notice Inviting Tender (04/0117/2017-W&S)**

Item rate sealed tenders are hereby invited in two envelope system, for the below mentioned work from the contractors, working with CPWD/ PWD/Railways/MES / P & T/ Govt. /semi govt./ and/or from those who had worked for CSIR or its laboratories & have successfully carried out (started & completed) the minm. one/two/three similar works (building work/ renovation/ up-gradation of bldg.) each costing not less than Rs. 50.80 Lacs/Rs. 38.10 Lacs/Rs. 25.40 Lacs respectively within last seven years, ending on last date of previous month.

1. The tenders shall not be issued physically. The interested and eligible parties are to download the complete tender document from website [www.nplindia.org](http://www.nplindia.org).

2. The tenderers shall be required to submit the bids in two envelopes (envelopes should superscribed with envelope no. & documents in envelope).

**Envelope- 1 :-** Will contain self attested copies of documents related to eligibility criteria, including the following:-

(A) Tender Fee & EMD in form as specified as above only.

(B) VAT registration/return filed within last six months ending on last date of previous month.

(C) Satisfactory completion certificates for similar works & minm. values as mentioned above. **The**

**completion certificate should contain all necessary informations including date of start & completion, completion amount & scope of work.**

In case any of the above documents is found missing or non satisfactory, the tender shall be rejected. No further clarification shall be sought from the tenderer. Envelope-2 of such agencies shall not be opened.

**Envelope-2 :-** Will contain Financial Bid including complete tender document available on website for downloading.

**Envelope-1 will be superscribed with envelope 1 containing tender fee, EMD, Vat regrn, & satisfactory completion certificates.**

**Envelope-2 will be superscribed with-Envelope 2 containing complete tender document downloaded from website after quoting rates.**

**The agencies are to follow two envelope system strictly as described above.**

**The tenderer are advised to enclose experience certificate more than minimum required as per NIT.**

3. Envelope-1 & 2 are to be **lakh sealed** separately. Both the envelope are to be sealed in bigger size envelope. The tenders are to be dropped in the box kept in the Civil Engg. Office latest by 11:00 AM on 19/05/2017.

4. The tenders will be opened on 19/05/2017, 11:30 AM, in the presence of tenderers or their representatives if any. Only Envelope-1 shall be opened on this date & time.

5. The bidders shall be qualified after scrutiny of credentials.

6. Envelope-2 shall be opened only of qualified bidders, on notified date & time, in the presence of qualified tenderers or their rep., if any. The notification shall be available on website.

7. When no rate has been quoted for any item, leaving space both in figures, words and amount blank, it will be considered that the tenderer has included cost of this item in other items and rate for such item will be considered as zero and work will be required to be executed accordingly. Tenderers must ensure that all the prints of downloaded document should be of good quality. Vogue /poor quality of printed documents and incomplete documents will not be accepted. The decision of TOC in the matter will be final.


8. If any tenderer withdraws the tender before award of work or makes any modification in terms and conditions of the tenders which are not acceptable to the department, then NPL shall without prejudice to any right or remedy be at liberty to forfeit 50% of earnest money.

9. Conditional tenders & tender with **use of fluid**, shall be rejected.

10. The validity of tender will be 90 days after opening of the same.

11. For electrical work the contractor will be required to produce proof of possessing valid electrical license or to get the electrical work completed through licensed electrical contractors only.
